

## **FIOCRUZ INSTITUTIONAL INTERNATIONALIZATION PROGRAM PrInt Fiocruz-CAPES**

### **Internal Call n° 05/2020 Selection of a PhD with Experience Abroad**

The Vice-Presidency of Education, Information and Communication (VPEIC), through the General Coordination of Education - CGE, makes public the call for Scholarships selection of PhD applicants (DEE – for the purposes of activities of research and teaching with Graduate Programs under the Institutional Internationalization Program - PrInt Fiocruz-Capes Program.. The General Coordination of Education (CGE) will be responsible for coordinating the selection process, dissemination of the result, management and execution of resources, according to the rules of PrInt Fiocruz-CAPES.

#### **1. PURPOSE**

- 1.1 The call for PhD with Experience Abroad - DEE - aims to encourage the attraction of researchers with experience abroad to work at Fiocruz, whose training and professional experience represent an innovative contribution to the Fiocruz Graduate Programs participating in the PrInt Fiocruz-Capes Program. It is expected that the performance of these doctors in the program will contribute to knowledge exchanges, create new academic environments with greater cultural and scientific diversity, fostering actions that positively impact the quality of graduates and research in the Fiocruz graduate.
- 1.2 The call for PhD with experience abroad specific objectives are:
  - a) Offer opportunities for updating knowledge and incorporating new modes or models of production and management of research in Fiocruz Graduate Programs;
  - b) Contribute to the process of internationalization of *stricto sensu* graduate studies and science, technology and innovation.
  - c) Strengthen cooperation and exchange programs between existing research network or institutions;
  - d) Contribute to the maintenance and/or establishment of scientific exchange in the area of Fiocruz Institutional Internationalization Project.
  - e) Expand the level of collaboration and joint publications among researchers working at Fiocruz and its partners abroad;
  - f) Expand fiocruz researchers' access to international centers of excellence;
  - g) Provide greater international visibility to Fiocruz's scientific and technological production.

## 2. THE CONDITIONS OF THE PROCESS

- 2.1 Professors and researchers, Brazilians or foreigners, with experience abroad, who reside in Brazil or abroad, may apply for the following categories:
- a) **Postdoctoral fellow:** Doctors, Brazilians or foreigners, living in Brazil or abroad, who have relevant academic-scientific experience proven abroad (full doctorate or postdoctoral studies for at least 12 months), who have interest in carrying out research and teaching activities at Fiocruz for a period of 6 months;
  - b) **Young Talent:** Brazilian or foreign doctors, residents and acting abroad for at least 12 months, at the time of application, who have relevant academic-scientific experience proven abroad and, at most, 10 years of obtaining the doctor's title, counted on the date of registration, to perform research activities and teaching at Fiocruz for a period of 6 months.
- 2.2 The scholarships of this Call will last 6 months.
- 2.3 The proponent of the submission of a Post-Doctor or Young Talent must be a professor, Fiocruz servant in effective exercise and acting in one of fiocruz's Graduate Program that participates in the PrInt Fiocruz-Capes Program, with the approval of the coordination of the Program.
- 2.4 The programs may present a joint proposal with other programs that are part of the PrInt Fiocruz-CAPES Program, aiming at maximizing efforts and better resource use. The proposal, in this case, will have only one proponent program, but explaining in the Work Plan the graduate programs participating with the respective approval of the Coordinators.
- 2.5 The proponent, whose candidate has been approved, must send within 30 (thirty) days after the completion of the work in Brazil of the Doctor with Experience Abroad a report of the activities carried out under the project in the Institution, containing a description of the courses, training, lectures or seminars, the activities fulfilled and other results obtained;
- 2.6 All communications under this Notice will be made through the email address informed by the applicant at the time of registration.

## 3. SCHOLARSHIPS AND BENEFITS

- 3.1 **10 Postdoctoral scholarships** and **4 Youth Talent scholarships** will be offered lasting 6 months. Applications for additional stay or the traineeship for less than 6 months shall not be accepted under this Call.
- 3.2 The objectives of each thematic network, the projects of activity and the graduate programs linked to these networks are presented in Appendix I of this Call.
- 3.3 Fiocruz will not charge administrative and/or academic fees or bench fees from the beneficiaries of this Call.

- 3.4 The benefits will be granted exclusively to the Postdoctoral or Young Talent and it does not depend on their family and salary condition, also the accumulation of benefits for the same purpose and same level is not permitted, thus the candidate should declare other scholarships granted by federal, state or municipal public administration agencies or entities and require their suspension or cancellation, so that there is no accumulation of scholarships during the study period.
- 3.5 The categories of **Postdoctoral** and **Young Talent** are independent to each other, and the relocation and exchange of one modality is not allowed.
- 3.6 They are financing items under the Doctor Program with Experience Abroad at Fiocruz:
- Scholarships in monthly installments, according to amounts stipulated in Appendix I to Capes Ordinance No. 1, of January 3, 2020 available in (<http://cad.capes.gov.br/ato-administrativo-detalhar?idAtoAdmElastic=3062#anchor>), to cover expenses related to activities in Brazil, such as teaching courses, training, interaction with faculty and student of the graduate program, lectures, face-to-face seminars;
  - Installation aid according to amounts stipulated in Appendix III of Capes Ordinance No. 1, of January 3, 2020 available in (<http://cad.capes.gov.br/ato-administrativo-detalhar?idAtoAdmElastic=3062#anchor>) paid in a single installment at the beginning of the concession;
  - Health Insurance Assistance, according to the amounts stipulated in Appendix IV to Capes Ordinance No. 1, of January 3, 2020, available in (<http://cad.capes.gov.br/ato-administrativo-detalhar?idAtoAdmElastic=3062#anchor>), for contracting health insurance with coverage in the country of destination;
  - Consumer material strictly necessary for the development of the project in the amount of up to R\$ 6,000.00 (six thousand reais), in accordance with CAPES' applicable ordinance and laws: Ordinance STN No. 448, of September 13, 2002 ([http://portalfns.saude.gov.br/images/banners/Sigem/Portaria\\_448\\_de\\_13\\_de\\_Setembro\\_de\\_2002.pdf](http://portalfns.saude.gov.br/images/banners/Sigem/Portaria_448_de_13_de_Setembro_de_2002.pdf)), Capes Ordinance No. 59, of May 14, 2013 ([https://www.capes.gov.br/images/stories/download/legislacao/Portaria\\_059-2013\\_AUXPE\\_SIPREC.pdf](https://www.capes.gov.br/images/stories/download/legislacao/Portaria_059-2013_AUXPE_SIPREC.pdf)); Capes Ordinance No. 08, of January 12, 2018 (<http://www.capes.gov.br/images/stories/download/legislacao/17012018-PORTARIA-N-8-DE-12-DE-JANEIRO-DE-2018-V.pdf>).
- 3.7 The candidate for postdoctoral studies with experience abroad, resident in Brazil, will be entitled according to item 3.6 point (a) and d and will not be granted the benefits of points b, c.
- 3.8 The amounts listed in points "a" a "c" of item 3.6 will be deposited by CAPES directly into the Doctor's bank account with Experience Abroad, whether in the Post-Doctor or Young Talent category.

- 3.9 The execution of item "d" will be carried out by CGE, after the implementation of the candidate's scholarship, by an e-mail request with a document signed by the scholar and supervisor (proponent professor) with the quotation of 3 (three) companies of the items described in the Plan of activities (Appendix III). If you need to purchase any other undiscriminated item on the form, you will need to provide a justification for including these items.
- 3.10 CAPES and Fiocruz will not grant tickets to companions or dependents.
- 3.11 Fiocruz and CAPES will not cover any costs other than those described in subitem 3.6.

#### 4. REQUIREMENTS FOR APPLICATION

- 4.1 The candidate for the **Postdoctoral** Scholarship must, according to item 2.1, meet the following requirements at the time of registration:
- Be Brazilian or foreign with a visa to remain in the country for the time of the project;
  - Reside in Brazil or abroad;
  - Have a doctorate degree recognized by the regulatory body in the country of origin and present it as a supporting document at the time of registration translated and validated by the Brazilian consulate in the country of origin;
  - Have relevant academic-scientific experience abroad for at least 12 months, highlighting this information in the curriculum vitae and presenting a statement from the institution of origin that attests to its experience.
- 4.2 The candidate for the **Young Talent** Scholarship must, according to item 2.1, meet the following requirements at the time of registration:
- Be Brazilian or foreign with a visa to remain in the country for the time of the project;
  - Reside in Brazil or abroad;
  - Have obtained a doctorate degree at least 01 (one) year ago and not exceed 10 years of doctorate, recognized by the regulatory body in the country of origin and present it as a supporting document at the time of registration translated and validated by the consulate brazilian in the country of origin.
  - Have recognized competence as a researcher in its area of activity, presenting a statement from the institution of origin that attests to this experience.
- 4.3 The candidate of Postdoctoral Fellow or the candidate of **Young Talent** should have relevant academic production in the last five years (2015 to 2020), related to the research area of the graduate program and the objectives of the PrInt Fiocruz-Capes Project chosen for work
- 4.4 The **Postdoctoral** candidate or the candidate **Young Talent** must, by requirement of CAPES, have the ORCID record that provides a unique identifier focused on the academic and research area. Registration is free and can be done on the website <https://orcid.org/>.

- 4.5 The **Postdoctoral** or the **Young Talent** candidate will not be able to accumulate the scholarship allocated in this Call with other scholarships in Brazil from CAPES or other federal, state or municipal public administration bodies or entities;

## 5. REGISTRATION

- 5.1 The submission of the proposal presupposes the knowledge and acceptance by the candidate(a) of the Regulation for International Scholarships abroad CAPES (Portaria Capes nº 289, de 02 de Janeiro de 2019) or subsequent normative acts that discipline the matter) and conditions of this Notice, of which the proponent and the candidate may not claim unawareness.
- 5.2 The proposals must be sent exclusively in PDF file, in a single email, to: [print.capes@fiocruz.br](mailto:print.capes@fiocruz.br), up to the deadline provided for in the schedule, having as the title of the subject: **Call nº 05/2020 – Postdoctoral or Young Talent**, according to the type of application, respecting the classifications of items 2.1 a) and b).
- 5.3 It will only be accepted, proposals forwarded with all mandatory application documents in PDF, submitted at the time of registration, which are:
- a) Specific registration form for the Doctor Program with Experience abroad fully completed, according to the chosen modality (Young Talent or Post-Doctoral Student) (Appendix II), duly signed by the proposing professor and candidate;
  - b) Updated curriculum vitae of the candidate in Portuguese, English or Spanish with data from the last 5 years (2015 to 2020), with emphasis on its 5 most relevant productions;
  - c) Acceptance letter from the Coordination of the Program(s) in which the candidate will act, expressing interest in receiving the candidate, as Appendix IV;
  - d) Two-sided copy of the doctor's degree;
  - e) Self-declaration of fluency in English for applicants who do not come from countries that have English as a native language;
  - f) **Activity Plan** according to Appendix III, with a maximum of 8 (eight) pages, in Portuguese, English or Spanish, drawn up in common agreement between the applicant (a) and (the) tenderers, and must contain the items specified below:
    - I. Title;
    - II. Summary;
    - III. Objectives, with clear definition and delimitation of the object of study;
    - IV. Justification of activities, presenting the merits, originality and relevance of the activities proposed in relation to the objectives of the Institutional Project of Internationalization of the Graduate Of Fiocruz;
    - V. Methodology to be applied;
    - VI. Description of the specific experimental or laboratory infrastructure, where applicable

- VII. Expected results;
  - VIII. Schedule of activities, compatible with the duration of the scholarship
  - IX. Predicted consumer materials;
  - X. Bibliographic references.
- 5.4 The documentation must be attached in PDF format, preferably in a single file. Only file that is less than 5(five) megabytes will be accepted.
  - 5.5 The information provided is the sole responsibility of the applicant and FIOCRUZ or Capes may exclude it from the selection if the requested documentation is presented with partial, incorrect or inconsistent data at any stage of the selection process, or even outside the specified deadline if it was subsequently found to be that untrue information.
  - 5.6 If there is divergence of dates for the beginning and end of studies in the documents presented – schedule of activities, manifestations of the institutions involved or any other documents, CGE and CAPES may reject the application at any time, based on documentary inconsistency.
  - 5.7 Also with regard to the divergence of the dates, if there is a request for reconsideration of the rejection decision or if the proponent timely submits clarifications, the committee may review the decision and arbitrate the period more consistent with the documents presented and compatible with the duration of the scholarship and the demand for which the candidate competed.
  - 5.8 Additional documents and information may be requested by Fiocruz or CAPES at any time for better instruction of the process and implementation of the scholarship.
  - 5.9 All communications under this Call will be made through the email address informed by the applicant at the time of registration.
  - 5.10 The proposal should be sent to the General Coordination of Education (CGE), the Vice-Presidency of Education, Information and Communication (VPEIC) of Fiocruz, with all the mandatory documents, as described in this item 5, within the deadlines presented in the schedule, exclusively by e-mail, to the following address to [print.capes@fiocruz.br](mailto:print.capes@fiocruz.br), indicating in the subject: **Call no. 05/2020 - Postdoctoral or Young Talent**, as per the application.
- 6. SELECTION**
- 6.1 The selection will be governed by this Call and executed by the General Coordination of Education, with the support of the Project Coordinators of PrInt Fiocruz-CAPES;
  - 6.2 The evaluation committee will be composed of the project coordinators of each of the Research Networks, according to Fiocruz Ordinance 1585/2018/PR. This committee will review and select the applicants
  - 6.3 If necessary, the General Coordinator of PrInt may convene members of the national or international steering committee, as well as *ad hoc* evaluators.



- 6.4 If the general coordinator or one of the project coordinators of one of the Networks is the proponent of any candidacy, he will not participate in the selection committee and a new internal or external member to PrInt Fiocruz will be invited.
- 6.5 **The evaluation process will encompass three stages:**
- Documentary analysis is eliminatory;
  - Analysis of the merits of the proposal will be eliminatory and classifier;
  - Final Classification
- 6.6 **Criteria for analysis and decision:**
- 6.6.1 **Technical/documentary analysis/approval of Registrations:**
- The candidate's requirements should be met on the expected date of selection;
  - Adequacy of the documentation presented by the applicant to the requirements of this call;
- 6.6.2 **Merit Analysis:**
- Relevance of the work plan with the PrInt Fiocruz-Capes project and its feasibility within the planned schedule;
  - Merit, originality and relevance of the Work Plan for the scientific and technological development and innovation of the country;
  - Previous experience of the Postdoctoral and Yong Talent applicant in the area of the project research, considering its relevant scientific, technological or innovative production, especially in the last five years (2015 a 2020);
  - Scientific quality of the proposal in the area of knowledge and its potential results;
  - Correspondence between the Activity Plan and the objectives of the Network(s) and Project(s) of print fiocruz-CAPES' performance, as presented in Appendix I of this Notice;
  - Impact potential in strengthening the interaction between Fiocruz and the foreign institution in which the applicant has a working relationship and generation of results that positively impact the development of teaching, research and extension of the Fiocruz programs
- 6.7 The final classification will be established by the descending order of notes, obtained by the sum of the points measured by the evaluators for each criterion described above, considering:
- 0 points - Unacceptable - incomplete or missing information.
  - 1 point - Weak
  - 2 points - Average
  - 3 points - Good
  - 4 points - Very Good
  - 5 5 points - Excellent
- 6.7.1 In case of a tie, the points obtained in criterion "d" and then in criterion "c" of item "6.6.2" will be used as a tiebreaker criterion.

6.7.2 The proposal that does not reach an average of 12 (twelve points) in the evaluation will be eliminated, even if all vacancies in your network are not filled.

6.7.3 The results of each selection stage will be published on the PrInt Fiocruz-CAPES (<https://print.campusvirtual.fiocruz.br/>) website and the selected applicants will be officially communicated, receiving instructions on the implementation of the scholarship by email.

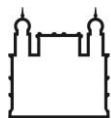
## 8. REPPORTS AND POST-ACTIVITIY DOCUMENTS



- 8.1 The proponent, whose applicant has been approved, shall send, up to 30 (thirty) days after the end of the term of the Post-Doctor scholarship or Young Talent, the following documentation:
- a) report of the activities developed under the project in the Institution, containing description of courses, training, lectures or face-to-face seminars and other proofs of productivity and impact.

## 9. GENERAL PROVISIONS

- 9.1 The replacement of the grant beneficiary or the transfer of the grant granted to another Young Talent abroad, or from him/her to a Postdoctoral applicant is not permitted under this call.
- 9.2 The submission of the proposal presupposes the knowledge and acceptance by the candidate of the Regulation for international scholarships of Capes (Capes Ordinance No. 125, of May 29, 2018) or subsequent normative acts that discipline the matter and conditions of this Notice, of which he cannot plead ignorance.
- 9.3 The candidate who does not have his candidacy admitted may forward resources following the schedule stipulated in this notice. The resources will be analyzed by the respective commissions and given knowledge by e-mail to the applicant.
- 9.4 Omitted or exceptional cases will be analyzed by the Print Fiocruz coordinator group (general coordinator and project coordinators);
- 9.5 At the discretion of the evaluation committee, with the approval of the General Coordination, it will be possible to relocate applicants between networks in order to maximize/optimize the use of scholarships.
- 9.6 This called will follow the indication schedule of scholarships available on the Capes website and is therefore subject to changes arising from changes in the opening dates of the CAPES system.
- 9.7 The granting of scholarships and benefits is prohibited to those who are in a situation of default with CAPES or are included in any registrations of delinquents maintained by organs of the Federal Public Administration.
- 9.8 After the selection and dissemination of approved applications, CGE will register the candidates selected and approved in CAPES's Scholarship and Aid Control System (SCBA), according to the schedule of implementation of scholarships presented by CAPES for the year 2020.

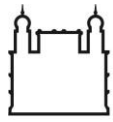

### **RICEI – Integrated Network of Science and Technology for coping with Emerging and re-emerging Infectious Diseases**

**OBJECTIVE:** To support actions that use the technologies available today in an integrated way to address gaps in the knowledge of the interaction of pathogens with their hosts, aiming to provide scientific subsidies for the development of new diagnostic, therapeutic and vaccine approaches. ### **RICRONI – Integrated network of non-communicable chronic diseases**

**OBJECTIVE:** To support actions based on the epidemiological transition in the country that shows an important growth in chronic non-infectious diseases, which is accompanied by the process of population aging, which require the urgent development of strategies to prevent the progression of this framework.

- Coping with metabolic diseases and aging
- Coping with diseases of an oncologic nature
- Coping with neuromuscular diseases, neurodevelopmental diseases and neurodegenerative diseases

### **RIDES – Integrated network to cope with health inequalities**

**OBJECTIVE:** To support actions that promote the confrontation of health inequalities manifested in different territorial scales, globally and within societies. Two aspects are the focus of this network: determination of health-disease processes (epidemiological, social, environmental dimensions); health systems and services (dimension of policies for promoting and health care of the population).

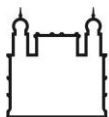

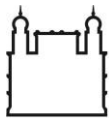
